- **Funds Transfer:** Supervisor DePiano motioned, seconded by Supervisor Ewald to transfer \$250,000 from the General fund to the Capital Reserve. There were no questions or comments. Motion passed.
- 3. **Bill List:** Supervisor Ewald motioned, second by Supervisor Malaico to approve the January Bill List in the amount of \$204,918.04. There were no questions or comments. Motion passed.

- 5. **Resignation of Planning Commission Member:** Supervisor DePiano motioned, seconded by Supervisor Ewald to accept the resignation of Harold Ernsberger to the EAC and Planning Commission. Discussion: Supervisor DePiano expressed that Mr. Ernsberger will be miss at both the EAC and Planning Commission.
- 6. Proposed Subdivision: Lot 202 Beechwood Dr (Ewald/Smith): *Supervisor Ewald presented Secretary Kernan with a memo to abstain from the vote on this subdivision due to a conflict of interest as a property owner. Supervisor DePiano motioned, seconded by Supervisor Malaico to approve the subdivision on the condition that the subdivision and joinder deeds be filed within 60 days of this decision. - 7. Proposed Land Development: Pocono Organic Farm

 *Supervisor Ewald presented Secretary Kernan with a memo to abstain from the vote on this subdivision due to a conflict of interest as an employee of the Pocono Raceway which is the property owner of the Pocono Organic Farm.

 Supervisor DePiano motioned, seconded by Supervisor Malaico to approve the Land Development with conditions. (Please see the Letter dated January 11, 2019 to Colwell-Naegele Associates, Inc. on file with the property record.) There was a discussion about the conditions. The motion passed.
- 8. **Proposed Investment:** The supervisors tabled this decision until the township researches local banks for CD rates.
- 9. **Proposed Zoning Ordinance Update:** Supervisor DePiano motioned, seconded by Supervisor Ewald to review the current Zoning Ordinance for typos and inconsistencies. There was a discussion about conflicting uses and conditional uses. The motion passed.
- 10. **GASB Report:** Supervisor Ewald motioned, seconded by Supervisor Malaico to pay the \$500 for the Government Accounting Standards Board (GASAB) report for the calendar year ending December 31, 2018 from the funds of the Pension. There were no questions or comments. The motion passed.
